Preamble:

In the SI. No. (01) read above, on creating Krantiveer Sangolli Rayanna Area Development Authority, the order has been issued.

In the SI. No. (2) and (3) as read above, in the meeting conducted under the Chairmanship of Hon'ble Chief Minister, it has been decided to start the Sainik School at Sangolli, Bailhongal Taluka, Dist: Belagavi and the order has been issued on approving the work of Rs. 15557.00 lakhs for the Sangolli Rayanna Smaraka Sainik School at Sangolli of Bailhongal taluka, Dist. Belagavi.

As read is the SI. No. 4 above, as the Sainik School is heing constructed at Sangolli of the Bailhongal taluka, Belagavi District, is at the final stage, The mentioned School has been examined by the three memberd committee and have informed the same to Hon'ble Chief Minister and Defence Minister, Govt. of India. Therefore in order to start the mentioned school, the Govt. of India on signing the memorandum of agreement have informed the defence dept. to take the School under the department.

In the Order No. (5) read above, the Sainik school society under the Union Ministry of Defense has been given permission to start the school in the academic year 2022-23 in collaboration with the Central and State Government, and it has been instructed to sign a Memorandum of Agreement with the Government of India by 31.03.2022.

In Order No. (6) read above, the Commissioner, Kranti Veera Sangolli Rayanna Development Authority has been given permission from the Union Ministry of Defense to start the Krantiveera Sangolli Rayanna, Sainik School and for the sainik school to make an agreement with the society the last date fixed will be 31/03/2022.In this background ,on behalf of the sainik school ,the chief secretary of the government, backward classes welfare have produced a proposal to sign on the agreement.

As read in the Sl. No. (7) above, in order to start the Krantiveer Sangolli Rayanna Sainik School from Std. 6th at Sangolli village, Bailhongal taluka, Belagavi district on behalf of the Krantiveer Sangolli Rayanna Area Development Authority as per the letter of Central Defence Dept., Sainik School Society dt: 25-03-2022, the proposal has been sent to issue a suitable order regarding the same.

On sending the mentioned file to the Finance Department the finance dept. in the ref (8), inorder to start the Krantiveer Sangolli Rayanna Sainik School, to sign the agreement with the Sainik School Society under the Central Defence Ministry, with subject to the condition that only the students taking admission from the state will be provided with the aid from the state Govt. the finance Dept. has given its consent.

On verifying the above mentioned points, the order has been ssued as below -

Government Order No. BCW 304 BMS 2022, Bengaluru, Date: 18-05-2022

In view of the factors described in the proposal, permission has been ordered to start the Krantiveera Sangolli Rayanna Sainik School from the year 2022-23 at Sangolli, Bailhongal Taluk, Belagavi District, in collaboration with the Sainik School Society under the Central Ministry of Defence, by enrolling 80 students in two sections of 6th class with 40 students each, at the first stage, subject to the following conditions.

- 1. To start the Krantiveera Sangolli Rayana Sainik School from the academic year 2022-23 as per rules.
- The said school shall be maintained as per the syllabus and rules laid down by the Central Government for Military Schools.
- Grants will be given by the state government only to the state students who get admission in the said school.
- 4. To use Rs. 3.00 Crores out of the Aid that has been provided to Krantiveer Sangolli Rayanna Area Development Authority under the Account Title 2225 03 190 0 06.059 by the Budget of 2022-23.
- To Strictly follow K.T.P. P. Act and Rules.
